A lawyer



A lawyer is a person who:



- knows and understands the law



- can help you with **contracts, leases** and other documents



- can give advice and information about:
 - your rights and responsibilities



- rules for your business



- how to buy or sell a business



- what to do when you do not agree with someone about the law

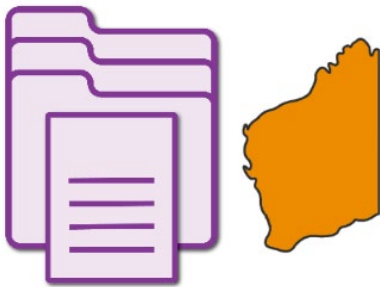

The Small Business Development Corporation (SBDC)

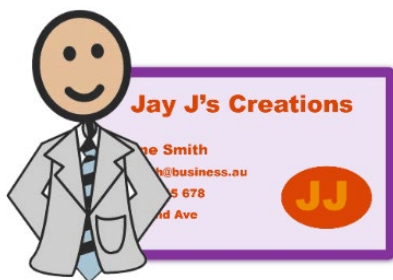


The Small Business Development Corporation gives information and advice to small business owners in Western Australia.

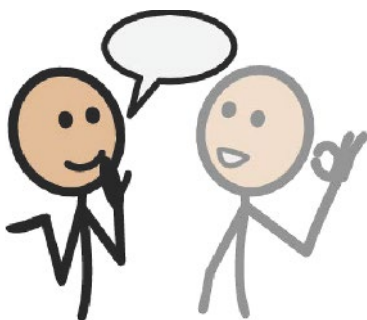


The Small Business Development Corporation has business advisors and lots of workshops.

A business mentor



A business mentor is someone who knows about owning a small business.



You can ask a business person you trust, to give you advice and support about starting your business.

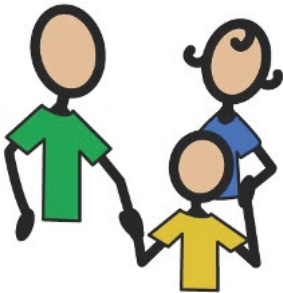


If you do not know a business person, you can contact the Small Business Development Corporation who have business advisors.

Your own group of supporters



They can be the people you trust, who care about you and know you well. They can be:



- family



- friends



- neighbours



- support workers



- other people in a paid role



Some of these people might know about owning a small business.



They might also be interested in your business and want to help.

Your supporters might help you with:



- deciding what things you are good at



- deciding what things you might need some help with



- deciding whether you have a good business idea



- thinking about different ideas



- thinking about other people who can help with your business



- going to workshops with you, if you want them to



- working out problems



- celebrating success with you



- listening about what you want to do with your business
