# What is this fact sheet about?



Your **income** is the money you earn from working.



You might pay some of your income to the Australian Taxation Office (ATO).

We call this **taxation**.



And when your employee earns an income, you might pay some of it to the ATO.

We call this **income tax**.

You must pay their income tax to the ATO.



**Pay as You Go (PAYG) withholding** is when you:

- keep some of your employee's pay then
- pay the ATO.

To pay tax for your employees using PAYG, you need to have:



- a Withholding Payer Number (WPN)

or



- an Australian Business Number (ABN).



We explain these numbers on the following pages.

# How to get a Withholding Payer Number (WPN)



A WPN is a number that tells the ATO:

- who you are
- that you are an employer.



If you don't have a WPN, you can download a form on the ATO website to apply for one.

You must fill out the form and send it to the ATO.



You can upload it to the ATO website.



Or you can send it by mail.

You can also send the form from your **myGov** account.



myGov is a website where you can get your:

- tax information
- medical information
- other government services.



You can also call the ATO to apply for a WPN.

# What to do if you already have an Australian Business Number (ABN)



An ABN is a number you need to have when you run a business or company in Australia.



You can't get a WPN if you have an ABN.

The ATO does not let someone have both.



If you have an ABN for another business, you can apply for a branch just for PAYG.



This keeps the PAYG tax separate from your other business.



To apply for a PAYG branch, you can visit the ATO website.

## Activity statements and paying employees' tax




An activity statement is a form the ATO sends you.

You need to fill out this form when you have an ABN or a WPN.



This form asks you for information about how much:

- money you paid your employees
- tax you keep from what you paid them.



You will get activity statements:

- every 3 months
- or
- once a month.



When you finish, you send your activity statements to the ATO.



You can send activity statements through your myGov account.



You might also get activity statements in the mail.



If this happens, you need to fill them out and mail them to the ATO.

The way you send activity statements might change if you use **Single Touch Payroll (STP)**.



STP is a type of program you can use to share information about your employees with the ATO.



From 1 July 2023, anyone who has a WPN must use STP.



If you have an ABN, you might already use STP.
